Wythe County Public Schools will be serving meals at no charge to children 18 and under. The U.S. Department of Agriculture (USDA) has approved waivers for local school divisions and other federal meal program sponsors to implement the Summer Food Service Program to provide meals to children in the community free of charge through May 27, 2021. The waivers support access to nutritious meals while minimizing exposure to COVID-19.

The new school year requires a new meal application. Although school meals will be provided free to all children, school funding depends on completed meal applications. A new meal application must be completed if you have not already been notified that your student is approved for free meals. It is important to submit a completed meal application as soon as possible.

- Only one meal application is needed for each household.

Meals will be delivered using Wythe County Public Schools' bus routes between 10:30 – 12:30 to children who have pre-ordered their meals through the appropriate school in their district.

October 12, 2020 – May 27, 2021

Meals will be available to children via four (4) options. **Option 1:** Children who choose to attend school beginning October 12th for in-person instruction on Mondays, Tuesdays, Thursdays and Fridays may receive breakfast beginning at 8:00 am and lunch between 10:30-12:30 pm. **Option 2:** Children who remain on distance learning instruction as well as any child between the ages of 1-18 years old may pick up meals on a first come, first serve basis, at any of the ten WCPS Cafeterias listed above between the hours of 10:30-12:30 p.m. Monday through Friday. **Option 3:** On Wednesdays and all district-wide distance learning days, between the hours of 10:30 am – 12:30 pm, meals will be delivered by WCPS school bus-routes to children that pre-order. **Option 4:** Meals will be provided, on a first come, first serve basis, for any child age 1 to 18 years old at the sites and times listed below on Mondays, Tuesdays, Thursdays and Fridays:
